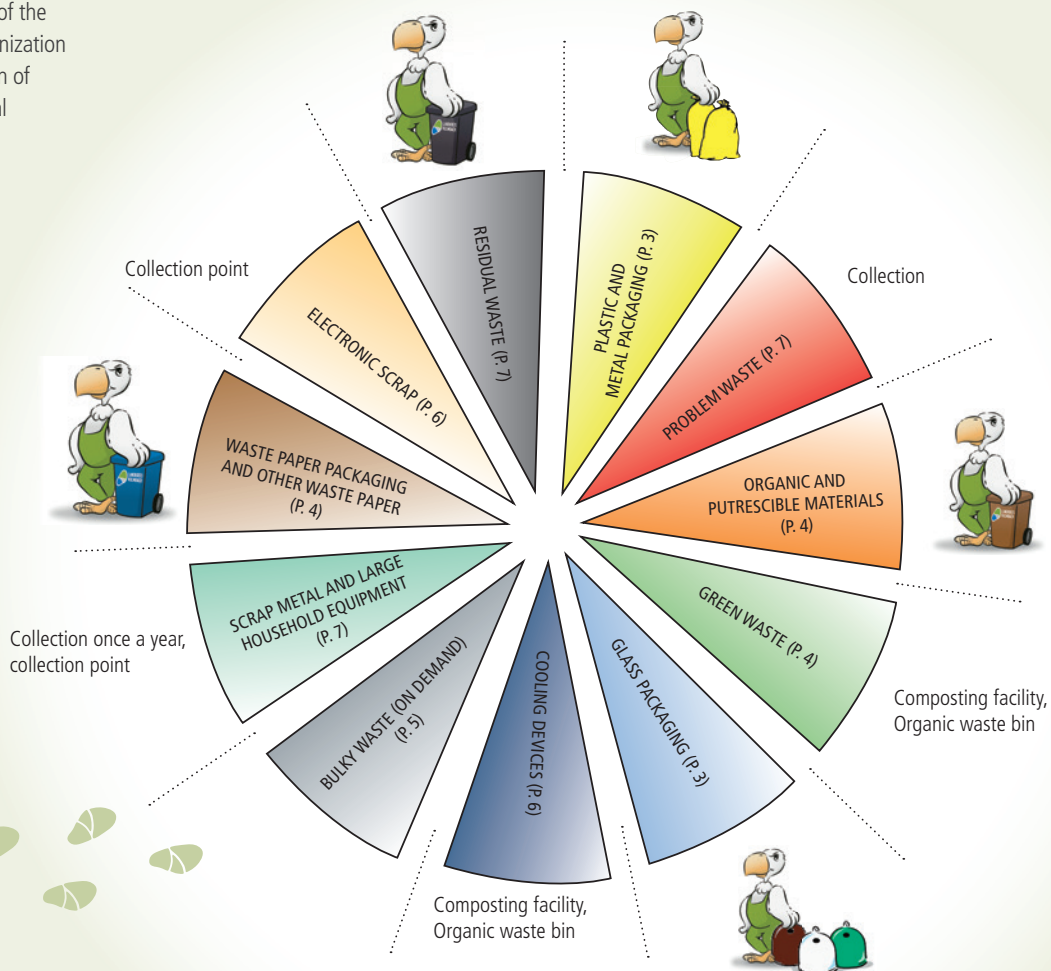

WHAT GOES INTO THE YELLOW RECYCLING BAG?



Important information: All packaging, which had previously been placed in the aluminium and tin containers, must now also be disposed of in the yellow recycling bag.

The container must not contain any liquids such as waste paint or waste oil. Please empty all containers and clean them roughly as required (to conserve fresh water, please only with already used dishwater). In addition, please do not use the yellow bags for purposes other than intended.

All disposable packaging of plastic, composites and polystyrene as well as disposable metal packaging:

- ✓ Moulded parts, such as bottles (e.g. for detergents and cleaning agents, shampoos, shower or bath lotions, adhesive or ketchup), pots (e.g. for yoghurt or margarine), trays (e.g. for fruit, quark, cookies or sweets), tubes (e.g. for cosmetics, toothpaste or mustard), small tubes (e.g. for fizzy tablets or straws or lip balm), gift ribbons, inserts (e.g. in chocolates or confectionary boxes) and screw caps
- ✓ Films (e.g. cling film), bags (carrier and freezer bags), film packaging (for food or confectionary, cosmetics or cleaning materials) and nets (for fruit or vegetables)
- ✓ Composites, i.e. packaging made from more than one material, such as drink cartons
- ✓ (e.g. for milk or juice) and vacuum packaging
- ✓ Polystyrene (clean and not laminated), moulded parts and chips as well as foamed packaging moulded parts
- ✓ Small parts made out of aluminium, such as crown caps, peel-off lids from yoghurt pots and aluminium foil
- ✓ Tin cans (e.g. drink, preserved products or aerosol cans - please only completely emptied!), tubes (e.g. for food or cleaning agents), tear-off lids of cans, tins and bottles (e.g. of aerosol cream containers - please, only emptied completely!), portion packaging (for jams, meat paste or evaporated milk)



The yellow recycling bag is collected every four weeks.

WHAT GOES INTO THE GLASS CONTAINER?

All glass non-returnable packaging:

(non-returnable) beverage bottles and all preserving jars (for vegetables, fruit or pickled preserves, jams, ketchup or baby food) and glass containers for pharmaceutical products, cosmetics or perfume - separated by the colours brown, green or white

We ask you to please remove foreign parts, such as plastic and metal, as well as to close caps and lids as best as you can. Please put glass of other colours, such as blue, yellow, or red glass or frosted glass in the green container

Please do not put into the glass container:

- ✓ Light bulbs (residual waste) and light fixtures (electronic scrap)
- ✓ Clay, porcelain, ceramics (residual waste) and stoneware bottles (yellow bag, as packaging!)
- ✓ Window, mirror and laminated glass (small volumes are residual waste, otherwise a private disposal firm is required)

Insertion is permitted only on workdays between 08:00 and 19:00! In the interests of the residents, please turn off the engine of your vehicle.

WHAT GOES INTO THE BLUE WASTE PAPER BIN?

All non-returnable paper packaging and all printed products:

- ✓ Cartons, paper bags and clean boxes, such as detergent boxes (please remove plastic handles!)
- ✓ Newspapers, writing, copy and shredder paper
- ✓ Magazines, illustrated magazines, catalogues and dividers
- ✓ Books and leaflets (please remove plastic jackets!)
- ✓ Envelopes

Please do not place in the blue bin:

- ✗ Beverage composite cartons (yellow bag)
- ✗ Paper combined with materials such as plastic, aluminium, as well as coated paper (packaging in the yellow bag, otherwise residual waste)
- ✗ Heavily contaminated paper (residual waste)
- ✗ Wallpaper (residual waste)
- ✗ Other valuable materials



The blue waste paper bin will be emptied every four weeks.

WHAT GOES INTO THE BROWN ORGANIC WASTE BIN?

All organic and putrescible waste:

- ✓ Organic kitchen waste, such as potato peel, salad, vegetable and fruit waste, eggshells, food and meal leftovers
- ✓ (in common household volumes) - no bones, please! (residual waste)
- ✓ Coffee and tea filters or grounds
- ✓ Sawdust and straw
- ✓ Feathers and hair
- ✓ Garden waste (including weeds and diseased plants); when possible, garden waste should be brought directly to the green waste composting facilities.

The following must not be put into the brown organic waste bin under any circumstances:

- ✗ Plastic bags or other non-compostable waste.
- Bins in which we find such materials will be given a red card by us and will not be emptied.

The brown organic waste bin is emptied once a week.

WHAT GOES TO THE GREEN WASTE COMPOSTING FACILITY?

All vegetable waste arising from gardening:

- ✓ Hedge, bush and tree cuttings, grass, leaves, twigs, houseplants, weeds and Christmas trees

The following must not be delivered:

- ✗ Meal leftovers and other kitchen waste, earth and stones, timber from demolition measures, dung, animal bedding, hay, straw, rootstocks

What else is to be observed?

Deliveries from the private environment in common household volumes are free of charge and do not need to be reported. Deliveries from public institutions as well as commercial and other enterprises are liable to charges. The volume delivered must be entered on the pre-printed form (to be found in the wooden boxes at the facility) with the date, address of the delivering person and the origin of the green waste and placed in the letter boxes on site. Infringements will be subject to fines.

WHAT GOES TO BULKY WASTE?

All bulky, moveable household items that can be burned.

- ✓ Bulky means: too big for the residual waste bin. Everything that fits into a bag or box is not bulky waste.
- ✓ Moveable means: not fixed to the house - i.e. everything that would normally be taken along when moving
- ✓ Burnable means mainly made of wood, plastic, textile or a mixture of these materials

The following are bulky waste

- ✓ **Furniture** → tables, chairs, benches, beds, sofas, cupboards, armchairs, sofas, sideboards, garden furniture
- ✓ **Furnishing items** → carpets, pictures, baskets, chests, pinboards, globes, interior blinds, flowerpots (burnable)
- ✓ **Toys** → Punch and Judy theatres, toy shops, blackboards, doll's prams, slides, rocking horses, sleds, drums, cuddly toys, pedal cars
- ✓ **Sports/leisure** → canoes, musical instruments (not electronic), fishing rods, dinghies, snowboards, skis, ski sticks, tents, table tennis tables, paddling pools
- ✓ **Other** → suitcases, air beds, projection screens, buggies, snow shovels, brooms, water butts

The following do not belong in bulky waste:

- × Waste from conversions, renovations or modernizations, such as, e.g. wastepipes, windows, doors, wooden floors and ceilings (laminated, parquet), garden fences, plasterboard, wash basins or toilet bowls. These must be disposed of privately at one's own cost.

What should be observed regarding bulky waste?

- ✓ Properties must be connected to the municipal waste collection service.
- ✓ Multiple dwelling units must jointly use the bulky waste appointments
- ✓ For bulky waste collections, properties with one waste bin are regarded as one property. Please indicate this when applying.
- ✓ If the property cannot be directly driven to by the waste vehicle, a handover location must be provided upon application
- ✓ The items must not be longer than 2 m and not weigh more than 50 kg.
- ✓ On the collection day, the bulky waste must be available at the place where usually the residual waste containers are by 06:00 a. m.
- ✓ Everyone is responsible for their own bulky waste. Waste that is not bulky waste and therefore cannot be collected, must be disposed of immediately and properly.
- ✓ Cupboards, drawers, suitcases, chests, etc. will only be collected without contents.
- ✓ Light fittings must be removed.
- ✓ From the specified collection dates, which take place at intervals of 4 to 10 weeks, a maximum of two per year and property may be used

WHAT IS INCLUDED IN ELECTRONIC SCRAP?

All electrical devices operated by electricity or batteries.

The consumer's obligation to return is incorporated in the so-called electrical and electronics equipment law. All electronic scrap must be disposed of at the municipal collection points.

Included in electronic scrap are the following:

- ✓ **Large household equipment** → e.g. ironing machines, fan heaters, ovens, coffeemakers, dishwashers, hobs, ventilators, fridges and freezers. Large household equipment can also be disposed of at scrap metal collection (once a year, dates will be announced nearer the time). For fridges and freezers there is a separate collection (see the info box alongside).
- ✓ **Information and telecommunications equipment** → e.g. devices from the PC area, copy and fax machines, telephones, electronic notebooks, calculators, electrical and electronic typewriters
- ✓ **Consumer electronics** → e.g. radios and televisions, video recorders, Hi-fi equipment and musical instruments
- ✓ **Toys, sports and leisure equipment** → e.g. electrical railways or race tracks, video game consoles, electrical sports equipment, e-bikes.
- ✓ **Small household devices** → e.g. vacuum cleaners, irons, toasters, deep fryers, coffee machines, electric knives, haircutting devices, razors, electric toothbrushes, alarms, clocks, balances, lamps.
- ✓ **Electrical and electronic tools**, e.g. turning, milling, grinding, crushing, sawing, shearing, drilling, punching, stamping, bending devices (with the exception of stationary, industrial large tools), electrical lawnmowers and other garden equipment
- ✓ **Photovoltaic modules** (common household volumes)
- ✓ **Night storage heaters** (removed and packaged by a specialist firm)
- ✓ **Products with fixed built-in electrical components** (e.g. footwear with lit-up soles)
- ✓ **Plugs and plug connectors**, adapters, audio cables, HDMI and USB cables, cable drums, extension cables, antennas, telephone sockets and jacks
- ✓ Toner cartridges and ink cartridges with electrical components, credit cards
- ✓ **Lighting fixtures** → e.g. luminaries for fluorescent lamps, tubular fluorescent lamps (neon tubes, compact fluorescent lamps (energy-saving lamps), discharge lamps).

Excluded from electrical scrap are the following:

- × **Stationarily operated equipment and devices** → e.g. production robots, mainframe computers (scrap metal trade)
- × **Installation material** → e.g. cables, switches, push-buttons, distributors, sockets and switch relays (residual waste)
- × **Components in electronic circuits** → e.g. resistors, capacitors, inductors and transistors (scrap metal trade, residual waste)
- × **Appliances that do not lose their primary function without electrical energy** → e.g. furniture with lighting (bulky waste, remove light fixtures)
- × **Appliances with other primary energy and extra electrical equipment** → e.g. petrol lawnmowers with electric starters (district administration scrap metal collection)
- × **Medical devices, implants** → e.g. heart pacemakers, blood sugar measuring devices (extra packaged in residual waste)
- × **All types of vehicles and vehicle accessories** → e.g. cars, car radios, car accessories, boats, forklift trucks (scrap metal trade)
- × **Batteries** → taken back at every sales outlet
- × **Ink cartridges** → taken back via the trade or collection at the District Administration office
- × **CDs and CD-ROMs** → collection at the District Administration office

Special rules for refrigerating units and mobile air-conditioners

Collections take place twice a year after preregistration on 09221 707-100.

Alternatively, there is an all-year round opportunity to hand them in to our collection point for electronic scrap at the firm of Drechsler, Von-Linde-Str. 6, Kulmbach.

Opening hours: Tues. 07:00 – 11:00,

Thurs. 15:00 – 19:00, Fri. 13:00 – 17:00 and Sat. 09:00 – 12:00

For non-private sources, such as industry, trade or business, the following regulations through by the ElektroG apply:

- ✓ There is no return obligation for disused electrical and electronic devices. Typical household devices covered by the ElektroG can be disposed of at no charge in normal household quantities at the firm of Drechsler, Von-Linde-Str. 6, Kulmbach.
- ✓ Opening hours: Tues. 07:00 – 11:00, Thurs. 15:00 – 19:00, Fri. 13:00 – 17:00 and Sat. 09:00 – 12:00.
- ✓ The delivery of large quantities of typical household devices is to be discussed with the District Administration on 09221 707 -199, -151 or -109.
- ✓ Devices not covered by the electrical and electronics equipment law, but which would not normally occur in private households (e.g. mainframe computers, stationary tools, etc.) must
...be disposed of by the owner of the device at their own expense, if it was placed on the market before 23.03.2006.
...be disposed of by the manufacturer of the device at their own expense, if it was placed on the market after 23.03.2006. The device must be brought to the manufacturer. Please ask the manufacturer about possible collection points

Meanwhile, the trade is also statutorily obliged to take back electronic scrap at no charge:

- ✓ Businesses with a sales area of more than 400 m² must take back old devices at no charge. Devices with an edge length of under 25 centimetres must always be taken back, regardless of whether you bought them in the specified shop or whether you are now buying a new device there.
- ✓ For larger devices, the principle "new for old" applies. If a device is sold, a device of the same category (e.g. a TV for a TV) must be taken back at no charge. The same applies if the device is delivered to your home. In this event, you must inform the trader when concluding the sale contract whether an old device is to be returned at delivery. This service must always be free of charge in respect of a stationary trader.
- ✓ The return obligation also applies to the online trade, but is, however, very differently executed. Please check this out before the purchase.

SCRAP METAL AND LARGE HOUSEHOLD DEVICES REMOVAL

Unlike the bulky waste collection, which since 2001 is only carried out by application, the removal of scrap metal and large household devices in the Kulmbach district takes place as before in the form of street collections once a year on fixed dates. No application is needed for this waste.

In accordance with the electrical and electronics equipment law, since 24 March 2006 large household devices must be handed over to the municipal collections. Disposal via the scrap trade or delivery as part of private scrap metal collections is no longer permitted.

Scrap metal includes:

- ✓ Aluminium ladders, baking trays, bed frames, frying pans, bicycles (without rubber tires), garden chairs, pedal cars, shelves, slides, shovels (without wooden handles), typewriters, sinks (without worktops), tables, trolleys, birdhouses, curtain rails, laundry racks, woks, tent poles, etc.

Large household items include:

- ✓ Ironing machines, baking ovens, steam cookers, convectors, microwaves, switch boxes, quick-response heaters, water heaters and tumble dryers

For year-round collection opportunities for large household devices there is our collection point at the firm of Drechsler, Von-Linde-Str. 6, Kulmbach. Opening hours: Tues. 07:00 – 11:00, Thurs. 15:00 – 19:00, Fri. 13:00 – 17:00 and Sat. 09:00 – 12:00

WHAT IS PROBLEM WASTE?

Problem waste is, for example:

All-purpose glue, drain pipe cleaners, batteries, brake fluids, chemicals, disinfectants, descalers, paint, varnish, wood preservatives, glues, drugs, brush cleaners, cleaning agents, turpentine, herbicides, diluents, zinc salves.

You can dispose of problem waste here:

- ✓ Monthly collection points of the District Administration in the industrial zone Am Goldenen Feld in Kulmbach, company premises of the firm of Drechsler, Von-Linde-Straße 17, open every 1st Saturday of a month from 09:00 to 12:00 (postponements are indicated in the collection calendar)
- ✓ 59 mobile collection points, in each case Wednesday 15:00 – 19:00, precise locations and dates at: abfall.landkreis-kulmbach.de or directly from the Abfallberatung (waste advice department)

WHAT GOES INTO THE BLACK RESIDUAL WASTE BIN?

- ✓ Leftover wallpaper
- ✓ Paper pocket tissues
- ✓ Nappies, bandages, napkins and dirty papers
- ✓ Blueprints, thermal paper
- ✓ Carbon and wax paper, backing paper of self-adhesive film and stickers
- ✓ Cigarette stubs and ashes (cold!)
- ✓ Adhesive tape and sharpener waste
- ✓ Animal bedding and bones
- ✓ Waste from the care area, such as disposable syringes and urine bags (packed in rigid containers)
- ✓ Used toothbrushes
- ✓ Vacuum cleaner bags
- ✓ Rags and leather
- ✓ Street sweepings
- ✓ Light bulbs and halogen lamps
- ✓ Expired food (with packaging)
- ✓ Dried-out emulsion paints (solvent-free)
- ✓ Bicycle tires
- ✓ Floor mats
- ✓ Photo albums
- ✓ Coat hangers
- ✓ Sport bags
- ✓ Toys
- ✓ Bicycle helmets
- ✓ Ski boots
- ✓ Rucksacks and school bags
- ✓ Hand brushes
- ✓ Toilet lids, etc.

The residual waste bin is emptied every 14 days..

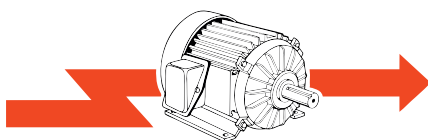
